News on New York Budgets

New York State Budget

On January 19, the Governor released a \$134 billion FY10-11 Executive Budget proposal that closes a \$7.4 billion deficit. This Budget contains **\$5.6 billion in recurring reductions** to current spending, which constitutes 75% of the gap closing plan. The Executive Budget also proposes **increasing taxes or fee liabilities** that will generate almost **\$1 billion** in FY11, about 14% of the overall gap closing plan. Note that the 21-day amendment period in which **the Governor can make changes to his formal budget proposal ends February 9th**. Over the next few weeks, the Legislature will hold a series of joint public hearings on the proposal and then typically begin negotiations with the Governor. Please see our Act Now! Section for more information about what you can do to help advocate for the sector.

The **Assembly published** its "Yellow Book," which is **a document that reflects the Ways & Means Committee's analysis of the Governor's budget**. It is organized with increases, decreases, and total funding summaries per agency; you can [click here](#) to see it. The **State Senate also published their summary of the Governor's proposed Executive Budget**, known as the "Blue Book," available [here](#).

New York City Budget

On January 28, the Mayor released his FY11 Preliminary Budget plan to **close a \$4.9 billion deficit through \$1.6 billion in agency gap closing options** (including \$484 million in reductions previously made for the remainder of FY10 and \$1.1 billion for FY11). HSC will complete a full analysis of the Mayor's FY11 Preliminary Budget and share it with members soon.

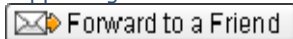
ARRA Update

In September and November, **HSC provided updates and grant information about federal stimulus funding through the American Recovery and Reinvestment Act (ARRA)**. We identified

Advocacy Results

As a result of HSC's survey and report about the difficulties being faced by not-for-profit human services agencies due to the economic crisis (the sole subject of our October 2009 newsletter), HSC developed a list of [recommendations for government agencies to help not-for-profits alleviate their financial and administrative burdens](#). We sent this list to New York State and City legislators and **worked with the New York State Comptroller's Office to implement these recommendations**. The Comptroller's Office embraced our recommendations and incorporated many of them in [their report on the not-for-profit sector](#). We thank them for their openness to working with us and look forward to continuing our work with the Comptroller and his Office on our shared issues of concern, such as the loss of public and private funding, prompt contracting, government efficiencies and assistance for not-for-profits as they struggle in the economic downturn.

HSC was thrilled to have received the first draft of the **Standard Human Services Contract** and to have gathered comments from our members on the draft documents. We have been advocating for the implementation of a standard approach to contracting and are excited to have reached this point. The new

opportunities that exist for not-for-profits to apply to the federal government for grants and forwarded these to our membership. Members can see our list of opportunities that remain open for submission, as well as tips for those interested in applying for these grants on the [Members-Only section](#) of our website.

HSC created [guidelines for future federal recovery spending](#) and wrote a [report](#) summarizing the issues faced by not-for-profits in addressing special ARRA reporting/tracking requirements that are unduly burdensome. We **shared these issues and recommendations with Senator Kirsten Gillibrand's Office** on the federal level and with **Michelle Light, Senior Policy Advisor, Mayor's Office of Operations**, on the City level.

We are planning a final ARRA training session in February to update members on how ARRA funds were used in human services for New York. HSC's ARRA work was made possible by a grant from the **New York Community Trust**, which ended in December.

Government Relations

contract **will be used across the City's human services agencies and will significantly reshape the terms and clauses of the sector's contracts.** HSC continues to lead the effort of a 60+ member workgroup through the negotiation process, ensuring the contract contains mutually agreeable terms and conditions. HSC is continuing to negotiate with the City on administrative rates and overhead, which will be incorporated into a City standard Fiscal Manual. We will submit our consolidated member comments to the Mayor's Office of Contract Services in February.

HSC was pleased to receive feedback from **government agencies that they are applying many of our principles for the FY11 State Budget** (discussed in the Act Now! section of this newsletter) to their difficult work of balancing the Executive Budget. The State heard our concerns for the sector on our recommendations for making targeted reductions rather than across-the-board cuts, pursuing revenue-raising proposals, and preserving programs that serve high-need communities.

When the City's Financial Management System (FMS) was temporarily shut down for upgrades from December 19 through January 3, HSC was notified in advance that FMS could not process contract payments during that period. **HSC's constant focus on the sector is ensuring that City agencies realize and measure the impact of their actions on our sector** and they are providing plans to minimize negative results. We appreciate that the Office of the Deputy Mayor for Health and Human Services recommended actions to minimize payment disruptions, which we were able to share with our members.

Upcoming Workshops

HSC is pleased to announce that we have negotiated a first-ever, limited-time discount for our members; the **Support Center for Nonprofit Management is offering 50% off all courses between now and June 30, 2010** if you are a member of HSC. (Typically, HSC members receive 25% off all courses.) The Support Center for Nonprofit Management is dedicated to improving society by helping nonprofit organizations and leaders through trainings and consulting services. Typical workshops include topics such as organizational and staff development, fundraising, financial management, and marketing and communications. On January 25, HSC hosted a **State budget briefing for our members** with **Kristin Proud, Deputy Secretary for Human Services, Technology and Operations; Lou Raffaele, Department of Budget (DOB) Chief Budget Examiner-Mental Hygiene; Todd Scheuermann, DOB Chief Budget Examiner-Human Services; and Dan Sheppard, DOB Chief Budget Examiner-Health.** The first hour was a briefing call by the State with an opportunity for Q&A on the Governor's proposed budget. Following the briefing with the Governor's office, HSC led a discussion on our advocacy strategy for this budget season with members in attendance.

On January 13, HSC was pleased to host **New York State Comptroller Thomas P. DiNapoli** at our Board of Directors meeting. We'd like to thank Comptroller DiNapoli and his staff for presenting to our Board. He mentioned two websites: [youmoneyny.net](#) provides New Yorkers with information to help face a variety of money-related issues, and [openbooknewyork.com](#) details State spending, such as the status of 60,000 current State contracts. We appreciate Comptroller DiNapoli's candor in his presentation and in answering our questions. The Comptroller ended his presentation on a high note: he runs the Office of Unclaimed Funds, which holds \$9B of abandoned properties for individuals and organizations in New York. The Comptroller's Office reported that **40% of our members have unclaimed funds** and presented a check for \$17,500 to Paul Levine of the Jewish Board

On January 12, HSC hosted a meeting where the **City presented its draft of the Standard Human Services Contract to our members.** Members had an opportunity to ask questions about the draft contract and learn about the City's perspective as the process for developing the standard contract for human services progresses. **Marla Simpson, Director, Mayor's Office of Contract Services; Louisa Chafee, Director of Management Innovation, Office of the Deputy Mayor for Health and Human Services; Jennifer Walty, NYC's Nonprofit Contract Facilitator; and Elisa Velazquez, General Counsel, Mayor's Office of Contract Services,** came to the meeting and we thank them for collaborating with HSC on this important work. Social Work, Division of Lifelong Learning and Professional Development. The Advanced Executive Leadership Certificate Program is intended for not-for-profit executives and emerging leaders from Social Work and related fields. Accepted seminar participants will meet for 8 bi-weekly sessions to examine issues, dilemmas and paradoxes they face in their agency work; strategy-planning models will be developed to address these issues. This program is under the direction of **Phil Coltoff**, Visiting Professor and Executive-in-Residence, and includes guest faculty, such as our own Michael Stoller.

The Winter/Spring schedule from the Procurement Training Institute (PTI) is out; remember that due to HSC's advocacy, **PTI classes are open and free to any not-for-profit provider with a City contract.** Some courses that might be of particular interest to HSC members are:

human services community we represent are strongly committed to antiracist work; we are thrilled that our Board of Directors reiterated its commitment to maintaining the momentum - despite the multitude of needs during these difficult economic times - by convening a task force on antiracist work in June, with two follow-up meetings during the summer and fall. Over a dozen Board members pledged to work on this important initiative with HSC.

The last meeting of the Strengthening Nonprofit Taskforce's Workgroup on Group Purchasing, headed jointly by **Gordon Campbell, United Way of NYC**, and Michael Stoller, took place on December 2; the next meeting is scheduled for February 3rd.

On November 18, Allison Sesso, HSC Deputy Executive Director, presented at a retreat on the impact of the reforms to the Rockefeller Drug Laws on human services providers. **HSC is helping to ensure that low-level drug offenders are re-integrated into society as effectively as possible**. We are working with our members, such as the **Drug Policy Alliance**, to find referrals and services for this population.
